Hello OMSD students, families, staff and community,

On April 2, 2021, I announced that Ontario-Montclair School District (OMSD) anticipated in-person instruction would safely begin on April 19, 2021. As promised, my office has vigilantly monitored COVID-19 infection rates in San Bernardino County and specifically within the OMSD boundaries.

I am excited to announce that effective, April 7, 2021, San Bernardino County has moved into the less restrictive Orange (Moderate) Tier of the State's Blueprint for a Safer Economy. The Orange Tier means the spread of COVID-19 has now reduced to a moderate level, as the number of cases continues to decline. Both **Goal #1** (two (2) million doses being administered to those in the lowest quartile of the Healthy Places Index) and **Goal #2** (four (4) million doses being administered to those in the lowest quartile of the Healthy Places Index) have been met and **OMSD is on-track to return to in-person instruction on April 19, 2021.**

*The County website does not provide an adjusted case rate by location/district, but the difference between the unadjusted and adjusted case rates have been negligible as of late.

Based on the most current COVID-19 data, all OMSD students in all grade levels will begin the in-person Blended Learning Model at all OMSD school sites on April 19, 2021. **This applies to students/families opting for in-person instruction through our Blended Learning Model.** Students/families who opted to remain on the OMSD Online Learning Model may continue through the end of the school year.

OMSD remains committed to providing a world-class education to all students.

As we return to in-person work/instruction, I want to again, remind everyone of the importance for continuing to social distance, mask wearing, washing hands frequently and other important safety protocols.
